Dundee Presbyterian Church MEETING OF THE CORPORATION

JANUARY 24, 2021

Moderator Senior Pastor Rev. J.D. Georlett of Dundee Presbyterian Church asked Chairman of the Board of Trustees Chris Blunk to call to order the Annual Meeting of the Dundee Presbyterian Church Corporation, established in 1901, on the above date in the church Sanctuary at 10:12 a.m., immediately following an adjournment of the Annual Congregational Meeting.

Rev. Georlett asked if a quorum of the Dundee Presbyterian Church membership was present. A quorum was present.

Chairman Blunk said the Trustees serve under the direction of Session of Dundee Presbyterian Church. He referenced a report on the work of Trustees in the printed 2020 Annual Report of Dundee Presbyterian Church, which refers to property and liability documents for the church building and an annual review of the church's financial records on file. Trustee Blunk said in 2020 the Corporation completed roof work, resolved water issues, installed a new lift and made repairs to the church's heating, ventilation and air-conditioning system.

Trustee Blunk reported the development of a master landscaping plan for the church grounds by the Garden Committee and the installation of a dramatic new outdoor lighting plan, which enhances the church's security. In addition, the church upgraded its computer system, while coming in under budget for the year.

Blunk said Dundee's financial revenue exceeded budgeted projections by \$151,002.64 for 2020, while the church's expenses were \$1,714.89 less than budgeted, contributing to a surplus budget for the second consecutive year.

Trustee Blunk thanked Trustees leaving and coming onto the board and Dundee staff for their outstanding work.

There being no further business, a motion to adjourn was made and carried at 10:17 a.m., returning to the Annual Congregational Meeting.

Dundee Presbyterian Church ANNUAL CONGREGATIONAL MEETING

JANUARY 24, 2021

The Annual Congregational Meeting of Dundee Presbyterian Church convened on the above date in the church Sanctuary and on Zoom. Senior Pastor Rev. J.D. Georlett asked the Session Clerks if a quorum of Dundee's membership was present. A quorum was present. Rev. Georlett called the meeting to order at 10:10 a.m. with prayer and scripture.

APPROVAL OF AGENDA: In a motion to adopt the printed agenda, Rev Georlett asked that the printed agenda be amended to move the Meeting of the Corporation to the next order of business.

The motion carried.

Rev. Georlett adjourned the Congregational Meeting at 10:11 a.m. to the Corporation Meeting.

Following the Meeting of the Corporation, Rev. Georlett reconvened the Annual Congregational Meeting at 10:17 a.m.

ELECTION OF CHURCH OFFICERS: Rev. Georlett gave a brief explanation of the nominating process and thanked members of the 2020 Nominating Committee, including Co-Chairs Elders Nancy Reiff and Stephanie Jensen, for their service.

Rev. Georlett presented the following nominations, all of which were approved unanimously by those present and voting. No further nominations were made from the floor. Confirmation was made of the study/preparation and examination required of the newly elected Elders and Deacons.

CLERKS REPORT: Co-Clerks of Session Chris Olson and Sheri Neve referenced minutes of the January 12, 2020, Annual Congregational Meeting and the Corporation Meeting and the 2020 Clerks Statistical Report. As Moderator, Rev. Georlett called for a motion to approve the three documents. There were no questions on the three documents.

The motion carried.

Co-Clerks noted in the Clerks Statistical Report for 2020 the list of members of Dundee Presbyterian Church who entered the Church Triumphant in 2020 and read their names:

A prayer of remembrance for the above departed members was offered. Confirmation was made of the use of Robert's Rules of Order in recording all Session action and business and the Session authorization of the sacraments of Communion worship services on the first Sunday of each month and baptism as requested. Rev. Georlett asked if the congregation had any questions for the Co-Clerks. There were no questions.

APPROVAL OF THE SENIOR PASTOR'S TERMS OF CALL FOR 2021: Co-Clerk Elder Chris Olson reported that Session had approved a 2021 budget that included an increase in salary compensation for Dundee Presbyterian Church Senior Pastor Rev. J.D. Georlett that would change his Terms of Call for 2021. While Session approves church budgets, the congregation is responsible for acting on any changes to the Terms of Call of pastors that they call to serve the church. Clerk Olson read the following motion:

MOTION: To approve a change in the Pastoral Terms of Call for the 2021 Pastoral Compensation Report of the Rev. J.D. Georlett, senior pastor at Dundee Presbyterian Church, to reflect a 3.2 percent increase in salary and housing allowance amounting to \$2,922.000, for a salary and housing allowance of \$95,622.00, plus corresponding commensurate adjustments in deferred compensation, based on Session's approved 2021 budget.

To allow for discussion of the motion to change the Pastoral Terms of Call, Moderator Georlett moved that the Annual Congregational Meeting go into a Committee of the Whole (executive session). The motion received a first and a second and carried at 10:32 a.m. Consequently, Rev. Georlett and his wife, Laura, left the Sanctuary, so that the initial motion might be discussed openly by the congregation.

At 10:36 a.m., Rev. Georlett and his wife were called back into the Sanctuary. A motion to return to the Annual Congregational Meeting received a first and a second and carried, returning the meeting to its previous status.

The moderator called for a vote on the change in Pastoral Terms of Call motion on the floor.

The motion carried unanimously, followed by applause of appreciation.

PRESENTATION OF THE 2021 BUDGET: Rev. Georlett outlined an approved and revised 2021 surplus budget of \$1,321,957.21, which is less than projected revenues of \$1,343,000.00 for 2021, creating a projected \$21,042.79 surplus. The 2021 surplus budget approved by Session on November 17, 2020, is Dundee's second consecutive proposed surplus budget in recent times.

The proposed revenue of \$1,343,000.00 for Dundee's 2021 budget is higher than \$1,300,000.00 in 2020 and \$1,229,500.00 in 2019, while anticipated expenses for 2021 of \$1,321,957.21 are higher than \$1,268,307.37 for 2020 and \$1,319,010.90 in 2019.

Projected pledged offerings for 2021 are the same \$825,000.00 as for 2020, but higher than \$816,500.00 for 2019. Despite the pandemic year, actual pledged offerings for 2020 exceeded projected figures by more than \$65,000. Unpledged offerings for 2021 are projected at the same \$200,000.00 as for 2020, but up from \$125,000.00 in 2019. The proposed transfer from the Endowment Fund for 2021 is the same \$265,000.00 as for 2020, but higher than \$227,900.00 for 2019.

Within the approved 2021 budget, projected administrative costs are down from 2020, but up from 2019. Support staff costs, including salaries, are down from 2020 and 2019.

2021 budget expenses are up from 2020 for Trustees maintenance costs and in mission giving through the use of carryover funding from previous years; the same for Christian education, health ministries, membership-events-and-outreach, Deacons, worship and small group ministry.

Rev. Georlett said Dundee's staff was to be commended for keeping expenses of the excellent ministries of the church consistent in such difficult pandemic times in 2021. Rev. Georlett asked the congregation for any concerns, questions or comments. There were none.

SENIOR PASTOR'S REPORT: Rev. Georlett drew the congregation's attention to Dundee Presbyterian Church's 20-member staff listed on Page 9 of the 2020 Annual Report, citing that each member of the staff had responded beyond the call of duty to address the daunting task of maintaining the excellence of Dundee's ministries during such an unusual pandemic year. Rev. Georlett referred to the All Things Considered... title of his written Senior Pastor Report and of the 2020 Annual Report in proclaiming 2020 – despite its reduced in-person attendance, Zoom meetings, masks, sanitizing, illnesses, staff changes and technology challenges – one of Dundee's best years...all things considered. He thanked Trustee Robert Welk for his work in 2020 to enhance and expand the exterior landscape lighting of the church building and grounds in honor of his late wife, artist Judith Welk. He also noted that the Dundee Presbyterian Church building and grounds had received a 2020 award from the Nebraska Statewide Arboretum Foundation for improvements to its landscaping, thanks to the overall work of Dundee's Garden Team Leadership Team. Rev. Georlett commended the leadership of Dundee's 54 Elder, Deacon and Trustee church officers in navigating Dundee though the perils of the pandemic year. Looking into 2021, Rev. Georlett said Dundee would be exploring how best to use the space within the church building for its current and future ministries.

COMMENTS AND QUESTIONS AND CONCERNS: Members of the congregation commended Dundee's staff as good and faithful servants in carrying on the church's strong ministries in 2020 in glory to God. Others said Dundee was bold in continuing both -in-person and online worship services in 2020, while many other church buildings remained closed. Many were grateful for the outstanding leadership of Senior Pastor Rev. Georlett and his wife, Laura.

NEW BUSINESS: No new business was presented.

There being no further business for the Annual Congregational Meeting, Rev. Georlett called for a motion to adjourn at 11:15 p.m. with prayer.

As we all know, 2020 was a year that was filled and defined by news of the Covid epidemic. Organizations like ours had to adjust and then readjust to regulations and restrictions having to do with the disease. In 2021, Dundee Presbyterian Church began to emerge from that time and started to return to familiar events and patterns and traditions.

As the year unfolded, I was quite regularly confronted with the question of how to return to things like Bible Study and Vacation Bible School and other church events, while also serving food and encouraging fellowship, all while continuing to observe safe practices. We did this by encouraging masks to be worn by those most at risk of transmitting the disease and by those who are most susceptible to its most extreme effects. We made sanitizer readily available and offered streaming video for many events to those who wanted and needed to stay at home.

In all things having to do with Covid, I have sought to allow everyone at Dundee to freely choose how they individually wanted to engage. Each member has always worked out their own worship life in their own unique way. I'm pleased to say that we have not lost that freedom. Everyone who has had opportunity to stay connected in the way that they felt was best for them. This will continue to be my priority.

As people became vaccinated, our attendance at worship and in other groups like the choir has slowly but steadily grown. We aren't at pre-pandemic levels, but I feel good about the progress that we have made, and I feel good about the number of new faces that we have seen.

We will have a financial surplus in 2021. This will be the fourth consecutive surplus that we have had. This consistent financial health has allowed me to work closely with the Session and particularly with the Trustees on several projects that are essential for the long-term health and vitality of Dundee Church. In other words, even as we have been working to emerge from Covid, we have been actively looking forward and making plans for the future.

We have finished what's called a master plan for construction and building improvement and we have developed renderings of possible improvements to the church. Over the next several months, these plans will be refined according to input from the congregation. It is encouraging that the work that has been thus far presented has been received with enthusiasm and positive support. My hope and intention has always been that these projects would be the work of the whole church and that it would bring us together in a unique way around a shared vision for the future ministry of the church.

The financing for these projects has come from the aforementioned surpluses that we have had for the last few years. Yet, in order to be fully successful, we will need to have a capital campaign. Because of this, we have contracted the services of Horizons Stewardship to guide us through the process of a campaign. They will lead us through a structured plan that is specifically designed for our congregation. This will be a capital campaign that will raise a significant amount of money for these projects, but more than that, it will be a spiritual journey for the whole congregation that will bring us together as we seek God's will, and joyfully respond to God's continued love and grace with generous giving and shared sacrifice.

These projects of improvement are professionally and personally important to me. I believe that I was called by God to serve at Dundee Presbyterian, and it has been clear to me from the beginning that, along with preaching the Gospel of Jesus Christ, it was my duty to lead this congregation through a season of self-examination and renewal. This is a great and very Holy work to which God has called all of us and I am thrilled to report that we have traveled well in the journey thus far and we are well positioned, at this point, to continue to follow Jesus into a wonderful future of ministry that will glorify God for generations to come.

CHILDREN & FAMILY MINISTRY

This year the Children's Ministry had an amazing year. It has been a blessing to serve God in helping fulfill the promise made at baptism to help the children grow in their faith, love, and relationship with our Savior, Jesus Christ.

KOW

Kids Own Worship occurs during the 9:00 a.m. and 11:00 a.m. services. The kids are dismissed after Pastor JD's Moment With Children and convene in the large group room upstairs to learn the sermon for that day on their level. We begin with prayer requests, pray, then a child leads us in the Lord's prayer. An opening activity engages the children to prepare them for the scripture readings and lesson. Questions and discussion are utilized to wrap up the lesson, then we do another activity and/or craft to reinforce the sermon's message.

Children's Choir and Bells

The children have had an amazing year practicing and participating in bell and choir performances thanks to Jonathan Mueller, Sarah Leonard, and Lisa Lever. Practices occur on Sundays at 9:45 a.m. following KOW and on Wednesdays at 6:45-7:15 p.m. This fall they were able to perform the bell choir in front of both services in the main sanctuary to the delight of everyone present. The children's choir had the privilege of performing with the adult choir for our annual Christmas Cantata and they looked fabulous in their robes of green and red, thanks to Jackie McLellan.

Sunday School

Sunday School has been meeting every Sunday from 10:00-10:55 a.m. during school months. The children have been learning great things about the Bible and Christ through the Gospel Project curriculum. We had a preschool/kindergarten class, a 1st-3rd grade class, and Club 4/5 class. This curriculum delivers a Christ-centered chronological bible study in age-appropriate ways.

DPC Kids Club

It was so refreshing to return to dinners on Wednesday nights. The children enjoyed fellowship through dinner, games, and DPC Kids Club. The Kids Club meets from 6:30-7:30 p.m. and contains lessons from the Buck Denver & Friends present Clive & lan's Wonder-Blimp of Knowledge Curriculum. Through this curriculum, the children have learned how to respond to God's love through prayer, praise, actions, and more. We took a break to celebrate Halloween with Minute To Win It games and prizes, and to do some Christmas curriculum during Advent.

Faith Milestones

This year Pastor JD was able to present our preschoolers and second graders with their very own bibles in person in the Sanctuary during both services. During Advent we had the second graders and a couple new members light the advent candles.

VBS

This summer we had a great showing of approximately 80 children during our week-long Vacation Bible School. The theme, Rocky Railway, was provided by Group Publishing focusing on a faith-filled adventure where the children discovered that trusting Jesus pulls them through life's ups and downs. This was evident by the loud cries of "Trust Jesus" that was heard as you walked around the church. So many great volunteers made this a blessing for all.

Service

The Children's Ministry was able to participate and represent our church in the Dundee Parade during Dundee Days. Handing out candy and invites was a joy had by all. We were also able to help with the Operation Christmas Child drive by building and filling boxes for others. It was wonderful to see eager participation in the children as they served others.

Fellowship

Families were able to enjoy a time of fellowship and fun during the Fall Rally Day, Holly Jolly Christmas Crafting, and Child-centered Christmas Eve service. The Rally Day included a bounce house, games, bubbles, and treats on the lawn. Holly Jolly Christmas Crafting included cookie decorating, making Christmas cards, snowflakes, and ornaments, and a grab bag station to take home and/or spread the Christmas joy. The child-centered Christmas Eve service had the theme of "Gift" this year focusing on Jesus, our Savior, as the greatest gift of all and incorporated a skit, the children's choir, and Wonder Place Preschoolers performing Away in a Manger in the Sanctuary. We were able to present each child with a gift of a baby Jesus ornament. The participation at these events was impressive.

WONDER PLACE PRESCHOOL

The preschool families were excited to start in person again this year, and our efforts to keep our environment safe and healthy have again resulted in zero cases of transmission within the classroom. Thanks to stream-lined safety measures, our teaching staff is able to focus on cultivating a Christ-centered learning environment for our students. It is exciting to see the light in a young child's eyes as they begin to understand the love Christ has for them.

This year saw changes to our Christmas curriculum, including introducing Bible verses in tandem to practicing songs for our Christmas program. We recorded our Christmas Program to enable the students to share it easily with friends and relatives. All of the preschoolers were able to tell others about the good news of Jesus' birth. They were invited to share this good news with their friends, family, and neighbors!

The curriculum continues to blend Bible stories into each day's lessons, and with the help of Dundee Music Director Mr. Jonathan, we're able to reinforce our Christian Themes through music on Thursdays and Fridays. In addition, the new Children's Ministry Director Liz Schaben will be joining us once a week to teach the Bible Theme starting in the spring semester.

The preschool remains self-supporting. This allows us to offer 10% of tuition to low-income families as scholarships. All scholarships are awarded based on the criteria used to receive free and reduced-price lunches. All of our families that receive assistance would not be able to attend a Christian program without help. We instill the Biblical call to service by engaging in three separate opportunities each year. We make Christmas cards for the Deacon bags for the homebound, we provide Halloween candy and treats for residents of the Ronald McDonald House and collect children's winter clothing items for Omaha's homeless shelters.

The average length of employment for the teachers has surpassed thirteen years, and we look forward to many more years of teaching children about Christ and instilling a love of learning. Each teacher is devoted to sharing their Christian faith with young children.

YOUTH MINISTRY

Youth Group Wednesday Nights

Youth Group meets almost every Wednesday of the year. The Middle Schoolers are on a 3 year study rotation, from January-May we finished up our life of Jesus series. Starting in August we began going through the New Testament, which we will study until May. In the 3 years that the students are in Middle School Youth Group they study the whole Bible, with a year's emphasis on Jesus's ministry. In High School Youth Group we have been studying a wide variety of topics and a few different books of the Bible. Youth Group is a great place for students to gather, and grow in their relationship with God, their peers, and their small group leaders.

Sunday Mornings

On Sunday mornings at 10 a.m. we have a much more laid back experience with a weekly small group Bible study. Students spend time in fellowship and eating donuts, followed by about 30 minutes of discussion on various topics from Scripture. We ended this year by looking at other religions and what they believe about God, thus really defining what it is that we truly believe about God.

Confirmation

This year our Confirmation class met on Sunday afternoons in the spring. We walked through what it means to be a personal follower of Christ, be an active member of a church congregation, as well as church history and Presbyterian Polity. Pastor JD taught a few of the classes. We had Deacons and Session members come and visit the class and share what they do in the church. We also confirmed our class of 2020, who were unable to be confirmed at the end of last May. The class of 2020: Andrew Demare, Miles Hamill and Andrew Marcoux. Our 2021 Confirmation Class: Maddi Newman, Skylar Rosengren, David Schaben, Elise Schaben, and Owen Wahl.

High School Mission Trip

This summer we took 8 high schoolers to Minneapolis, MN to serve with Praying Pelican Missions. While we were there we served with a variety of local missions, mostly serving in food relief ministries. The students prepped food packs to be handed out to homeless people—they packed about 1000 packs which were able to be used for the next 2 months! The team also spent time packing up Manna Packs with Feed My Starving Children to help those in need around the world. The process included dumping vitamins, veggies, soy, and rice in a pack and then sealing it closed.

The team also prayed for each box that was going to be sent out. Our team was able to pack up 47 boxes—enough to feed 28 kids for a whole year! The students really enjoyed partnering with Feed My Starving Children and being a small part of their big mission. The team spent the next day sorting food and hand delivering groceries to cars. The trip was a wonderful experience for everyone involved.

Middle School Mission Trip

We spent a weekend this summer with our Middle Schoolers serving in Omaha. We spent time serving with Scatter Joy Acres, Abide Omaha, Open Door Mission, and The Hope Center. During this weekend the students were stretched by serving in a variety of different ways, and discovering all the different ways God has gifted each of them.

Seven11s

Seven11s are events that begin at 7 p.m. and end at 11 p.m.; usually about eight events a year. These Seven11s are designed as opportunities for students to bring friends and just to have fun. This year we did a variety of fun things; we went to an Escape Room, Papio Fun park, played games at the church, had a costume party at church, and had a Christmas party. It is through these events that we draw in a number of new students to share in fellowship together.

Youth Room Updates

This year we have been in the process of refreshing our youth spaces. We've done lots of exciting things! We aren't quite done yet, but what's done looks great so far. We added a small snack bar in the youth room with a sink, along with new carpet, seating and fresh paint. These updates have been so great for the students and the program.

Youth Leaders and Volunteers

We have some amazing small group leaders that help out every single Wednesday night. They facilitate discussion with our students, but they do so much more than that. They love and pray for these kids and show them the love of Jesus in the way they live.

One participant had not been hugged for five years! It was a true reminder of our need for connectedness to our Lord and to one another. Everyone has a life story, and caring unconditionally and without judgment is what it's all about.

BOARD OF TRUSTEES

TRUSTEE CHAIRMAN'S MESSAGE

2021 has been a blessed and challenging year for Trustees. The Church came out of the pandemic in solid financial condition. Early in the year, Session set aside \$450,000.00 for building improvements and maintenance as prioritized by Trustees.

From the physical plant side, the most pressing needs of the building were prioritized and addressed. The Youth Educational Wing is in the final stages of its renovation, and members are encouraged to visit to see the updated and inviting area to foster and engage our youth.

Next, the entry and security of the Church was addressed. An updated security/entry system has been installed. This system comes with remote monitoring, motion activated lights, and high-resolution security cameras. This allows the staff to monitor points of entry and who has been in the facility.

Finally, the aging HVAC system is starting to be addressed. The educational wing is moving to a new HVAC system that will integrate with any future upgrades to the main boiler system. This gives the Church the added bonus of removing 30% of the boiler's load as we continue to move to current technology for the whole building.

To address long range needs of the facility in 2021 is quite an accomplishment for Dundee. Additionally, the Church came in on budget for 2021 as I write this report.

As we look to 2022, there is continued progress on advancing a Capital Campaign. Session has authorized the Trustees to pursue the Capital Campaign and to take the next step in finalizing the Facilities Master Assessment Plan into actual designs.

I want to thank all of the Trustees for their dedication and service in serving through a challenging and interesting year.

We, as Trustees, want to thank the heavy lifters, Jann Jarosz and Heather Ruhter, for patiently answering our questions and requests.

ENDOWMENT COMMITTEE

ANNUAL REPORT OF THE ENDOWMENT COMMITTEE 2021

December 17, 2021

Committee Directors (10): Jean Putrino, Chair; Bob Meyer, Vice Chair; Don Hosford, Secretary; Robert Cochran, MD; Charles Downey; Vicki Hallett; Howard Kennedy (resigned mid-year); Clark Landers; Jeff Moran, Trustee Representative; Anna Castner Wightman; and Dennis Riekenberg, Church Treasurer. Non-voting: Frank Gaines, Session Representative; and Rev. J.D. Georlett.

The Endowment Committee is charged with directing the investment of the Endowment Fund and donations to the Fund. This year the Fund began with a balance of \$5,961,604. A sum of \$278,291 was withdrawn to support the church budget and missions, and \$5358 investing fees were paid. As of November 30, 2020, the fund is valued at \$6,271,184. This result beat our blended benchmark by one-half percent (0.5%).

The committee met quarterly, often by Zoom, and called two special meetings. One meeting was devoted to considering proposals solicited from seven investment advisory firms. Interviews were conducted with finalist firms. After careful study, a majority voted to continue with First National. At another meeting, Horizons Stewardship presented its proposal for helping prepare a planned giving initiative, and ideas how the endowment could participate in a capital campaign. At two of our meetings advisors from First National Bank reported in person, took questions, and provided a learning module. At the urging of First National, at the October meeting the asset class "Alternatives" was restored to the list of permitted investments with allocation limited to between 0%-10%.

The committee will vote on a slate of new member nominees in January, when Bob Meyer will become Chair.

The endowment serves a holy and critical Christian purpose to safeguard DPC's mission and to enhance DPC's programs in perpetuity. We have inherited this blessing which we seek to preserve and enhance through wise management and by God's Providence.

STEWARDSHIP AND FINANCE COMMITTEE

A Stewardship Drive was held during three weeks of October, culminating with Pledge Card Sunday on Sunday, October 31st. This event was coupled with a celebration of the Kirkin' of the Tartan and was very well attended.

As of January 10, 2022, the church has received a total of 143 pledges totaling \$853,203. That leaves us 10 short of the total pledges that were received last year, with the average pledge almost exactly equal to what we had received in the last year. Both 2021 and 2022 are down from our peak in 2020 when we received 162 pledges. Though a bit stagnant, these numbers are actually very good in comparison to other churches during this time of Covid-19 and high inflation.

We are hoping to rejuvenate our Stewardship patterns in 2022 with a fresher approach to Stewardship in the Fall under the guidance of Horizons Stewardship. They are also leading us through the details of a capital campaign.

As will be explained in greater detail during the Annual Meeting on Sunday, January 23rd, we finished the fiscal year of 2021 with a budget surplus of \$285,241. This was due to the fact that we received 111% of our projected revenues, continuing a trend in which more and more people give to the church without pledging. The surplus was also the product of spending that was 9% lower than projected.

OPERATIONS

It's been very exciting to have the building get busier again. As always there were major heating challenges when the boilers were started up again this year. We continue to have leaks, and parts that need to be repaired and replaced, due to the age of most of our boiler system in and under the building.

Boiler inspections revealed corrosion and buildup that needed to be removed before it could pass inspection. A chemical treatment has been installed to prevent the buildup in the future. When the corrosion was cleared away several leaks were revealed in the one unit that was not repaired last year. The "re-tubing" has been completed and now we have 2 working boilers once again. During all the repairs to the interior of the boiler there were also weeks of repairs being done to leaky valves, thermostats, pipes etc everywhere else in the building. Thank God for Harry Tkaczuk who takes care of all the HVAC needs of this old beauty.

One of the most exciting things happening this year is the decision to convert the northern 1/3 of the building to a new VRF heating and cooling system. Work will probably not start on that until after the beginning of 2022. This will be a wonderful improvement that will also allow us to cap-off the antique underground pipes to that portion of the building. Less hidden piping to develop steam leaks! The intent is to convert the whole building, in phases, from the old boiler system to this new and much more efficient system.

This year the Trustees approved installation of a new security system that included replacing cameras and door locks on exterior doors. We have much better visual coverage of the interior of the building and outside doors to greatly improve our security.

All of these improvements have taken into consideration other potential improvements to the building in the coming few years and will be easily adapted to the new plans when they happen.

I look forward to seeing what next year brings!
